WALKING HOLIDAYS



RULES & GUIDELINES

Walking Holidays allow tour groups to provide their customers with the options of gaining IVV stamps whilst touring parts of Great Britain & Ireland where no IVV walks or Permanent Trails exist.

SHORT DISTANCE WALKING HOLIDAYS

The organiser must:

- Provide a walk on at least 60% of the days that they will be in the UK or Ireland, these can be Walking Holiday events, scheduled events or Permanent Trails
- Walks must be a minimum of 5km and a maximum of 15km
- Walks may be led by a responsible member of the organising group or walkers may be provided with a written route description
- Venues and proposed distances must be agreed at least 4 weeks prior to the start of the Holiday
- All fees must be paid before any stamps will be dispatched to the address provided
- A separate IVV stamp will be supplied for each walk.

GUIDED WALKING HOLIDAYS

The organiser must:

- Provide a walk on at least 60% of the days that they will be in the UK or Ireland, these can be Walking Holiday events, scheduled events or Permanent Trails
- Walks must be at least 10km and not more than 30km in length. A separate distance of between 5km & 10 km is desirable.
- Walks between 10 & 30km must be led by a guide familiar with the area, however walkers on a distance between 5 & 10km can either be led by a guide or supplied with a written route description.
- The guide must ensure that the speed of the walk suits the slowest walker. If necessary, then a number of walk groups may be arranged to cope with the varied abilities of individual walkers. Each group must have a separate guide.
- Venues and proposed distances must be agreed at least 4 weeks prior to the start of the Holiday
- All fees must be paid before any stamps will be dispatched to the address provided
- A separate IVV stamp will be supplied for each walk.
